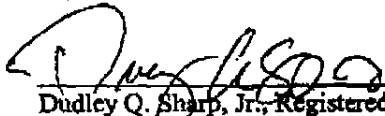

**ARTICLE V — Management:**

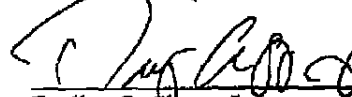
The Limited Liability Company is to be managed by the Members and is therefore a Member-Managed Company.
