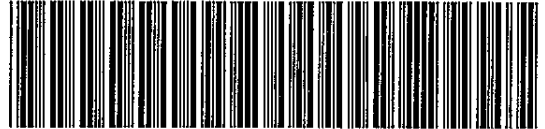

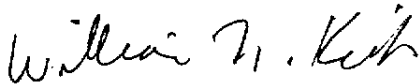

ARTICLES OF ORGANIZATION  
FOR

The undersigned, being authorized to execute and file these Amended and Restated Articles, of Organization hereby certifies that:

**FIRST:** The Articles of Organization for the Limited Liability Company were filed on July 12, 2005, and assigned document No. L05000068346. Such Articles of Organization were corrected by Articles of Correction filed on August 1, 2005.

**SECOND:** Amended and Restated Articles of Organization for the Limited Liability Company are as follows:

**ARTICLE I -- NAME**

The name of the Limited Liability Company is:
