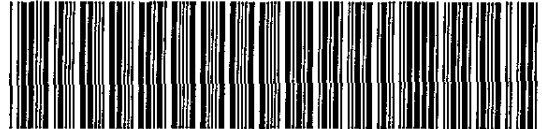



Name. The name of this limited liability company is: **Visionary Restaurants Concepts, LLC.**


