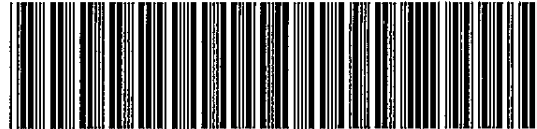


**ARTICLE VII




