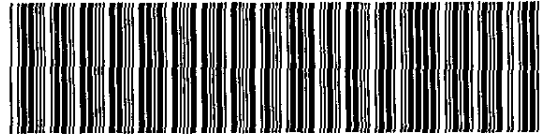

ARTICLE 1. NAME AND ADDRESS

ARTICLE 2. COMMENCEMENT AND DURATION OF EXISTENCE

ARTICLE 7. AMENDMENT OF ARTICLES OF ORGANIZATION

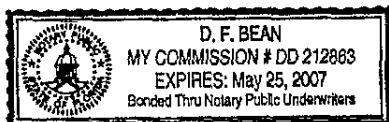


