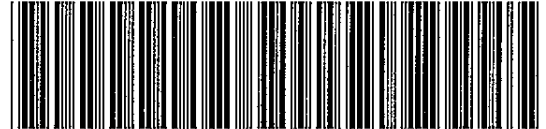



**FIRST:** The Articles of Organization were filed on July 11, 2005 and assigned document number L05000068885.


