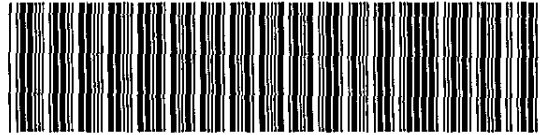

ARTICLE VII - AMENDMENT




