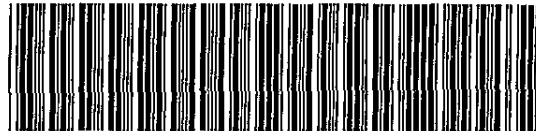

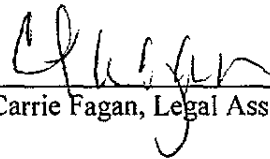

**ARTICLES OF ORGANIZATION
OF
KRANZ INVESTING, LLC**

The undersigned members adopt the following Articles of Organization pursuant to the provisions of the Florida Limited Liability Company Act (the "Act").

**ARTICLE I
NAME OF COMPANY**

The name of the limited liability company is Kranz Investing, LLC (the "Company").

**ARTICLE II
PERIOD OF DURATION**

The Company shall terminate on July 6, 2105.

**ARTICLE III
REGISTERED OFFICE AND AGENT**

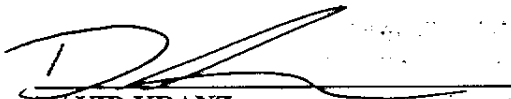
MANAGEMENT

The Company is organized for any legal and lawful purpose for which a limited liability company may be organized pursuant to the Act.

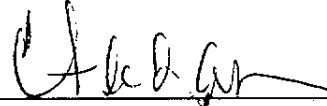
