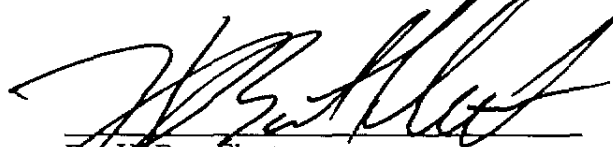
WRITTEN STATEMENT
