ARTICLE I Name

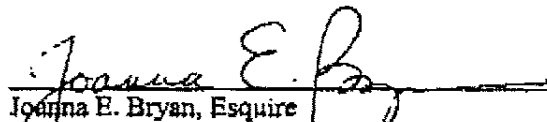
The name of the Company is: **HOME DYNAMICS SEDONA, LLC**
