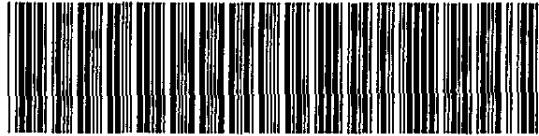

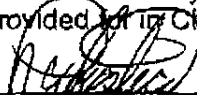

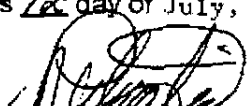
Article VI
