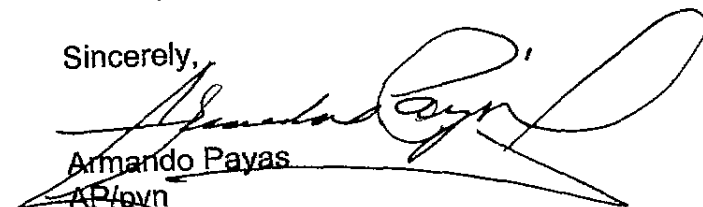

ARTICLES OF ORGANIZATION

Of

ARTICLE I

Name and Duration

The name of this Limited Liability Company is, VALORE INVESTMENTS, LLC. (hereinafter referred to as the "Company"). The duration of the Company shall commence upon the filing of these Articles of Organization and shall be perpetual.

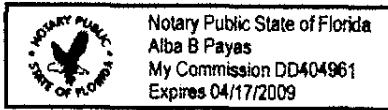
