ARTICLES OF ORGANIZATION

OF

MDE ENTERPRISES, LLC

A Florida Limited Liability Company



ARTICLE I Name

The name of the limited liability company is MDE ENTERPRISES, LLC. (the "Company").

ARTICLE II Principal Office

The mailing address and street address of the principal office of the Company is 8788 Southwest 8th Street, Miami, Florida 33174.

ARTICLE III Duration

The period of duration for the Company shall be perpetual.
