#### ARTICLES OF ORGANIZATION

OF

#### 211 COMPANY, LLC

#### A Florida Limited Liability Company

#### ARTICLE I Name

The name of the limited liability company is 211 COMPANY, LLC. (the "Company").

### ARTICLE II Principal Office

The mailing address and street address of the principal office of the Company is 8788 Southwest 8<sup>th</sup> Street, Miami, Florida 33174.

### ARTICLE III Duration

The period of duration for the Company shall be perpetual.

The transferee shall therefore entitled to receive only the share of profits actually distributed or other compensation paid by way of income and the return of capital contributions to which the transferring member otherwise would have been entitled by virtue of membership, or otherwise in accordance with the provisions of the operating agreement of the Company.

### ARTICLE XI Members' Rights to Continue Business

The death, retirement, resignation, expulsion, dissolution, bankruptcy, dissociation or withdrawal of any member, or the occurrence of any other event that terminates the continued membership of any member shall not cause the Company to be dissolved or its affairs to be wound-up, and upon the occurrence of any such event, the Company shall be continued without dissolution and without any affirmative action or requirement on the part of the members.
