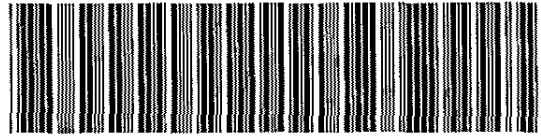

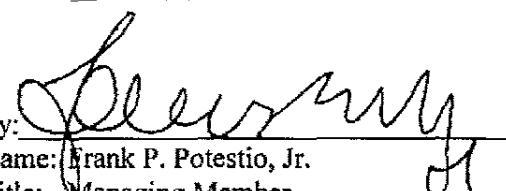
#### **ARTICLE VII ADMISSION OF NEW MEMBERS**

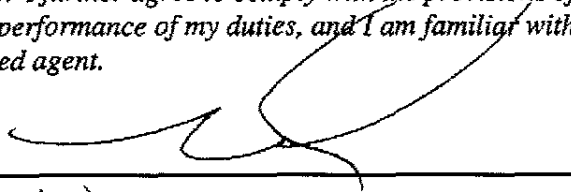
