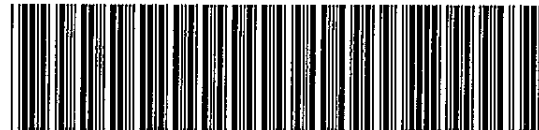

ARTICLES OF ORGANIZATION

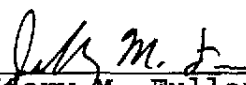

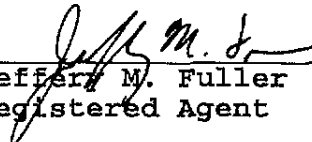
CERTIFICATE DESIGNATING REGISTERED AGENT
