ARTICLES OF ORGANIZATION of TALLYHOMES, LLC

STATE OF THE STATE The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes (the "Florida Limited Liability Company Act"), for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

1. NAME.
