ARTICLES OF ORGANIZATION

OF

LARRY DALÉ PARRISH DRYWALL, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be LARRY DALE PARRISH DRYWALL, L.L.C..

ARTICLE II -- ADDRESS

The mailing and street address of the principal office is $2120~{\rm NE}~40^{\rm th}$ Street, Ocala, FL 34479.
