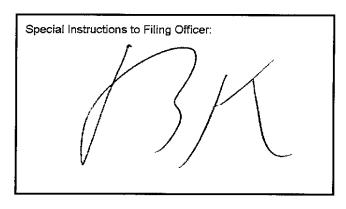

AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF **CGDGCG PROPERTIES, LLC**

(Filed in accord with 608.411, F.S.)

SOR AND SOR The undersigned, acting under the provisions of Chapter 608 of the Florida Statutes entitle the Florida Limited Liability Company Act (the "Act"), hereby amends and restates the Articles of Organization of CGDGCG PROPERTIES, LLC, filed with the Florida Department of State on July 19, 2005, as follows:

Name

The name of the limited liability company is CGDGCG PROPERTIES, LLC (hereinafter referred to as the "Company").

Period of Duration

The period of duration of the Company shall be from the date of filing of these Articles of Organization until the first to occur of the following:

- The date that is twenty (20) years from the date of filing of these Articles of Organization with the Florida Department of State.
- Dissolution of the Company under the provisions of the written operating agreement signed by all of the members as then in effect (the "Operating Agreement"), or as required under the Act.

<u>Purpose</u>

The purpose for which the Company is organized is to engage in any and all business and activities permitted by the Act and any other applicable laws of the State of Florida. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

Address Of Place Of Business

The mailing address for the Company is 276 Harbor Lane North, Massapequa, NY11762, and the street address of the place of business for the Company is the same. These addresses may be changed from time to time as provided in the Operating Agreement.

Registered Agent

The initial registered agent in Florida for the Company is Denise Greco, and the initial registered office is located at 5103 S.W. 13th Avenue, Cape Coral, Florida 33914.

Capital Contributions

Contributions to the capital of the Company shall be made by the member(s), in the manner prescribed by the written Operating Agreement made and entered into by the member(s) and which may be amended from time to time in accordance with its terms.

Members

The Company shall have at least one member and may admit additional members on the prior unanimous written agreement of the then existing member(s), or as otherwise provided in the Operating Agreement.

Management

The overall management and control of the business and affairs of the Company shall be vested in its member(s), as provided in these Articles of Organization, and section 608.407 of the Act or as otherwise provided in the Operating Agreement.

Indemnification

Except as expressly provided in the Operating Agreement, the Company shall indemnify any member, manager, or former member or manager to the full extent permitted under the Act.

Managing Member

The name and address of the managing member is Raymond Gucciardo, 276 Harbor Lane North, Massapequa, NY 11762.

These Amended and Restated Articles of Organization have been duly executed on <u>Occepher 13</u>, 2005, and are being filed in accordance with Section 608.411, Florida Statutes.
