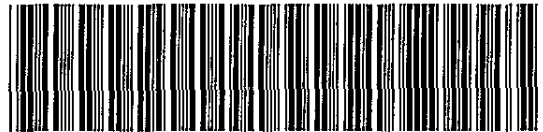

**ARTICLES OF ORGANIZATION
OF
DISASTER RELIEF SERVICES, L.L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be Disaster Relief Services, L.L.C. (the "**Company**").

ARTICLE II – ADDRESS

The mailing address and street address of the principal office of the Company shall be 30326 Fairway Drive, Wesley Chapel, Florida 33543.

ARTICLE III – DURATION

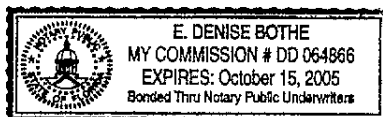
