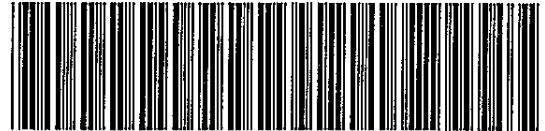

ARTICLE OF ORGANIZATION


1. **Name.** The name of this company shall be Rentech LLC


5. **Management of Company.** The company is to be managed by members. The name and address of the members to manage are:


