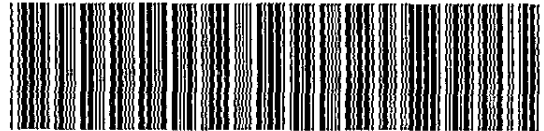

**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
DARSHAN GROUP, LLC
(A Florida Limited Liability Company)**

Pursuant to the provisions of Section 608.411, Florida Statutes, this Florida Limited Liability Company adopts the following amendment to its Articles of Organization:

FIRST: The Articles of Organization were filed on July 13, 2005, and assigned document number L05000070796.

SECOND: The following Amendment was adopted such that *Articles II and III of the Articles of Organization* shall be amended to read as follows:

**ARTICLE II
Address of Business**
