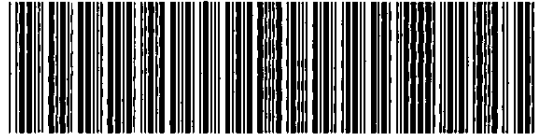

TO THE ARTICLES OF ORGANIZATION OF  
OCEAN WATERS SUPER 8, LLC  
(Changing its name to 133 South Ocean, LLC)**


Pursuant to Chapter 608 of the Florida Revised Statutes, Ocean Waters Super 8, LLC, a Florida limited liability company (the "Company"), hereby adopts the following amendment to its Articles of Organization:

1. **Name of Company.** The name of the Company is Ocean Waters Super 8, LLC.
2. **Date of Formation.** The Company filed its Articles of Organization on July 24, 2001, under Florida Document Number L05000071207.
3. **Amendment to Articles of Organization.** By consent of the sole member of the Company, the Articles of Organization of the Company are hereby amended to change the name of the Company to "133 South Ocean, LLC". Wherever in said Articles or in any operating agreement adopted pursuant thereto the name "Ocean Waters Super 8, LLC" shall appear, the same shall be deleted and the name "133 South Ocean, LLC" shall be substituted in lieu thereof.
4. **Effective Date of Amendment.** This Amendment shall be effective upon filing with the Florida Department of State.
