ARTICLES OF ORGANIZATION OF GRAPHIC SIGN SOLUTIONS, L.L.C.

The undersigned certifies that he is acting as the organizing Member for the purpose of GANG STATE forming a limited liability company under the laws of the State of Florida, providing for the hand of the limited liability companies for profit.
