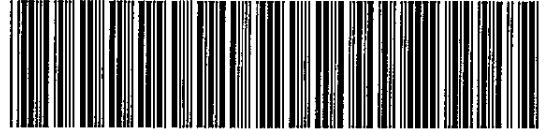

Through this scholarship fund we will be assisting children who have lost a parent to brain cancer or a child whose parent is battling brain cancer go to college at a community college or university. The student must be degree seeking, and going to school FT.
