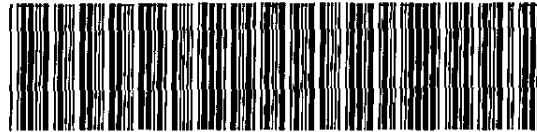




Admission of Additional Members


