**SECOND:** The period of its duration shall be perpetual.


**THIRD:** The mailing address and street address of the principal office is 11790 Metro Parkway, Suite A, Fort Myers, Florida 33912.

**SIXTH:** The persons executing these Articles of Organization are members or the authorized representative of a member of the Limited Liability Company.


