FIRST: The name of the Limited Liability Company is:


ELD Development, LLC



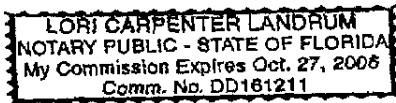
