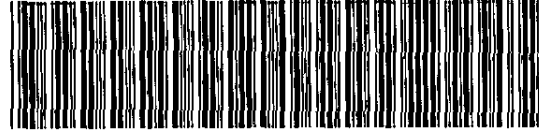

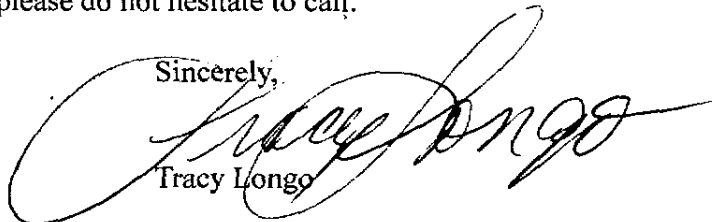

**ARTICLES OF ORGANIZATION  
OF  
MWM INVESTMENTS OF SOUTH FLORIDA, LLC**

The undersigned hereby forms and establishes a limited liability company under the laws of the State of Florida.

**ARTICLE I**
