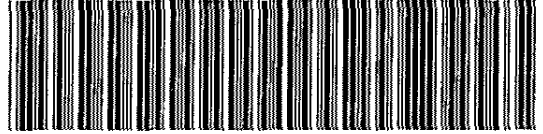

SECOND: The following amendment(s) to the Articles of Organization was/were adopted by the limited liability company:


1. Brian Holloway is no longer acting CEO or registered agent of Playmaker X LLC. He will be removed from all Playmaker LLC articles.
