The name of the limited liability company is: Crystal Sands 510, LLC.

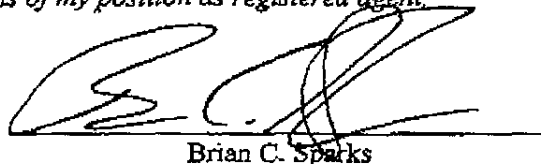
ARTICLE II. ADDRESS

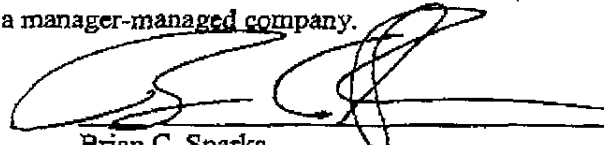
