ARTICLES OF ORGANIZATION OF SOUTH HAVEN PARTNERS, LLC

- 1. Name. The name of this limited liability company is SOUTH HAVEN PARTNERS, LLC, a Florida limited liability company (the "Company").
- 2. <u>Duration</u>. The Company shall be effective upon the filing of these Articles and shall thereafter have perpetual existence.
