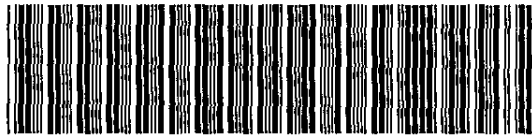

ARTICLES OF AMENDMENT  
TO ARTICLES OF ORGANIZATION  
OF  
SEMINOLE APARTMENTS, LLC

The undersigned SEMINOLE APARTMENTS, LLC, a Florida limited liability company, (the "Company"), in accordance with the provisions of Chapter 608, Florida Statutes, hereby amends its Articles of Organization as set forth below:

1. The name of the Company is SEMINOLE APARTMENTS, LLC.
2. The Articles of Organization for the Company were filed with the Florida Department of State on July 22, 2005.
3. Article VI of the Company's Articles of Organization is hereby deleted in its entirety and the following is substituted therefor:

"ARTICLE VI.
