ARTICLES OF ORGANIZATION

The undersigned, being duly authorized to act as the organizer of this Limited Liability

Company pursuant to Chapter 608 and Section 658.16, Florida Statutes, hereby forms a limited liability company under the laws of the State of Florida and adopts the following Articles of Organization for such Limited Liability Company.
