**FIRST:** The name of the Company is: North A Properties, LLC

**SECOND:** The Articles of Organization of the Company were filed on July 22, 2005 and assigned document number L05000072702.

**THIRD:** Article 4 of the Articles of Organization of the Company is hereby amended and restated in its entirety as follows:

**SIXTH:** The foregoing amendment to the Company's Articles of Organization will become effective upon the filing of these Articles of Amendment to the Articles of Organization with the Florida Department of State.
