1. The Articles of Organization of APEX (PALM BAY) MANAGER, LLC, a Florida limited liability company, were filed with the Florida Department of State, on July 22, 2005.

2. Article 6 of the Articles of Organization is hereby deleted in its entirety and the following Article 6 inserted in lieu thereof:

"Article 6 – Principal Office

3. Article 7 of the Articles of Organization is hereby deleted in its entirety and the following Article 7 inserted in lieu thereof:

"Article 7 – Management

The management of the business and affairs of the Company shall be vested in its member and the name and address of the current managing member is Larry Sweat, 215 E. Davis Boulevard, Tampa, FL 33606."

4. Article 8 of the Articles of Organization is hereby deleted in its entirety and the following Article 8 inserted in lieu thereof:


"Article 6 – Registered Agent and Registered Office
