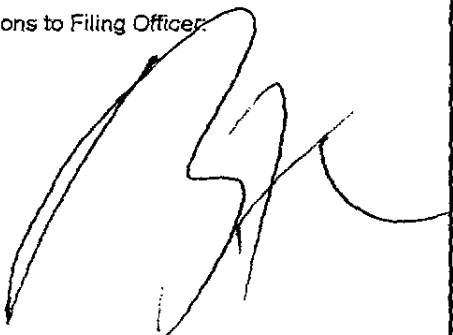

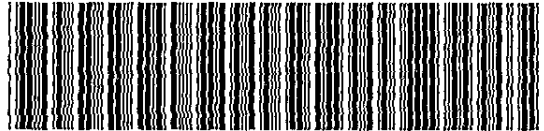

WHEREAS, the Articles of Organization of INDEPENDENCE LAND DEVELOPMENT 23, LLC (the "Company") were filed with the Florida Department of State on July 22, 2005 as Document No. L05000072728; and

WHEREAS, it is the intention of the Sole Member of the Company that the Articles of Organization of the Company be amended, effective the date this Amendment is filed with the Florida Department of State, in accordance with the proposed amendment hereinafter set forth; and

WHEREAS, the proposed amendment to the Articles of Organization of the Company as hereinafter set forth is hereby approved by written consent of the Sole Member on the 16th day of August, 2005.

NOW, THEREFORE, the Articles of Organization of the Company are hereby amended effective the date this Amendment is filed with the Florida Department of State, as follows:

1. Article IV is deleted in its entirety and the following is substituted therefore:

The powers of the Limited Liability Company shall be exercised by or under the authority of, and the business and affairs of the Limited Liability company shall be managed under the direction of its Manager and is, therefore, a manager-managed company.
