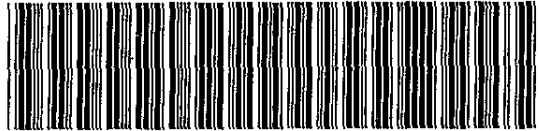


## ARTICLE VI: ADMISSION OF ADDITIONAL MEMBERS


Additional Members may be admitted upon the approval of a majority of the Membership, upon the written application of such member and in a manner set forth in the Regulations of the Company.




