Third: The date the dissolution was unanimously approved by all the Members was November 27, 2006.



Fifth: Adequate provision has been made for all the debts, obligations and liabilities of the limited liability company pursuant to Section 608.4421.


Sixth: All remaining property and assets have been distributed among its members in accordance with their respective rights and interests.
