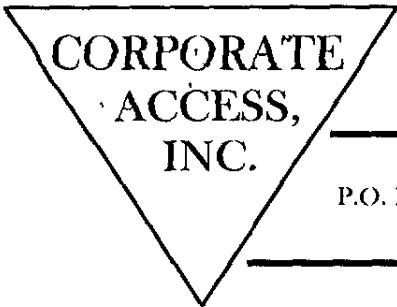

**ARTICLE V- Purpose, Owner(s), Prohibitions & Exclusions:**

- a) The main purpose of Limited Liability Company is to provide more flexibility in managing/ directing the Self-Directed IRA account investments.
- b) The Self-Directed IRA Account # 53755 held with Equity Trust Company F/B/O Teerawee Unchalipongse is the initial ***Sole Owner*** of this Limited Liability Company. The Self-Directed IRA owner has the right to move the custody of his account holdings to another financial institution. Consequently, upon such move, the new Self-Directed IRA custodial account becomes the ***Sole Owner*** of the Limited Liability Company.
- c) The IRA Account Owner and LLC Manager shall fully comply with the Internal Revenue Code (IRC) and Regulations, and the ERISA Rules and Regulations Governing Individual Retirement Accounts' Prohibitions, Exclusions and Prohibited Transactions.
