



ARTICLES OF DISSOLUTION**

SOMERSET PROPERTIES, LLC, a Florida limited liability company, executes the following Articles of Dissolution pursuant to Section 607.1403, Florida Statutes:

- FIRST: The name of the corporation is SOMERSET PROPERTIES, LLC (the "LLC").
- SECOND: The LLC's Articles of Incorporation were filed on July 21, 2005.
- THIRD: The LLC has four (4) Members with voting rights. The Members approved these Articles of Dissolution by adoption of a resolution by written consent executed in accordance with Section 607.0704, Florida Statutes. The number of votes cast by the Members in favor of the dissolution as evidenced by execution of the written consent is sufficient for approval of the dissolution.
- FOURTH: The LLC has no unpaid debts.
- FIFTH: The date of adoption of the resolution by the Members to dissolve the LLC was April 22, 2019.
- SIXTH: The number of members in office at the time of the vote was four (4) and the vote in favor of the dissolution resolution was four (4), which was sufficient for approval.
- SEVENTH: The effective date of these Articles of Dissolution shall be April 22, 2019.
