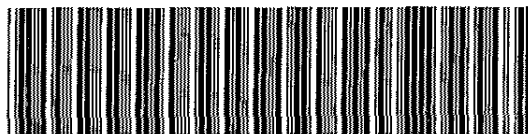

**ARTICLE I
NAME**

The name of this limited liability company is Pelican Bay 441, LLC, referred to in these Articles of Organization as the "Company."

**ARTICLE II


