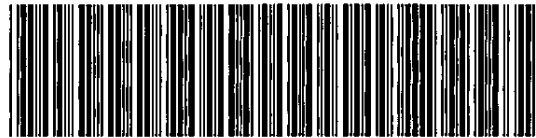

FIRST: The Articles of Organization of Brickell Trust Title LLC (the "Company") were filed on 07/26/2005 and assigned document number L05000073428


