

## ARTICLES OF ORGANIZATION OF DIRECTTOCONSUMERS.COM, LLC

- SILL PARTIES Name. The name of this limited liability DIRECTTOCONSUMERS.COM, LLC (the "Company"), and it shall be formed as a lim liability company under Chapter 608 of the laws of the State of Florida.
