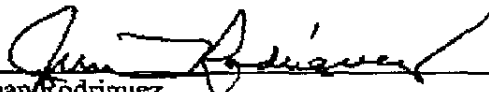

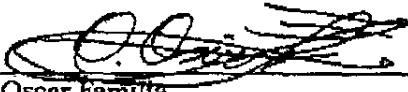
ARTICLE XI CLASSIFICATION

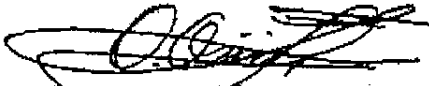
