ARTICLE 4 - REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the company in the State of Florida is William R. Merkle, 1901 South Congress Avenue, Suite 120, Boynton Beach, Florida 33426.

ARTICLE 5 - CAPITAL CONTRIBUTIONS

of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer in written consent. Any member, however, may transfer his or her interest to his or her revocable trust of which the member is Trustee and that has been established for estate planning purposes by such member.






