AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF 2005 LEM TURNER ASSOCIATES, LLC

Pursuant to the provisions of Section 608.411, Florida Statutes, this Florida limited liability company adopts the follow Articles of Amendment to its Articles of Organization:

The original Articles of Organization filed with the Department of State on July 27, 2005 for the corporate entity 2005 LEM TURNER ASSOCIATES, LLC should be struck in its entirety and the following inserted in lieu thereof.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I NAME AND ADDRESS
