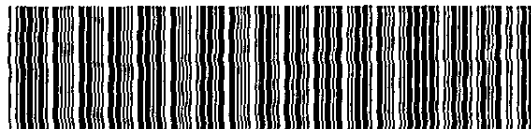

ARTICLE II - ADDRESS




ARTICLE IX - ADDITIONAL PROVISIONS


