### A FLORIDA LIMITED LIABILITY COMPANY

The undersigned desiring to form a Limited Liability Company under and pursuant to Section 608.404 of the Limited Liability Act, pursuant to Chapter 608 of the Florida Statutes, of the State of Florida, do hereby certify as follows:

FIRST: The name of said Limited Liability Company shall be HIGHLAND LAKES, LLC, and the mailing address and the street address of the principal office of the limited liability company shall be: 1115 N.W. 17th Avenue, Hollywood, Florida 33020.

SECOND: HIGHLAND LAKES, LLC, shall have a perpetual duration from the date of filing of these Articles of Organization.

THIRD: The purposes for which, HIGHLAND LAKES, LLC is formed are:
