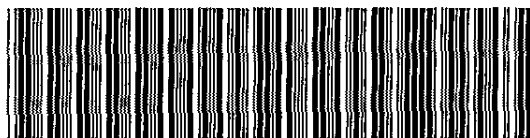

Article I is amended to state "The name of the Limited Liability Company is Brewer Technologies, LLC."


